Your privacy is important to The Crewing Company, as is your trust in The Crewing Company products and services. We want you to know that the information you share with us will be treated with care. Scope

Information Collection

The Crewing Company may obtain information about you in a number of ways: For example, our websites, business reply cards, incentive applications, surveys, and other public sources. Our use of cookies

We use a variety of types of cookies for the following purposes:

- **Performance cookies:** these cookies allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. - **Functionality cookies:** these cookies are used to recognise you when you return to our website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region).
- Targeting and marketing cookies: these cookies record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose, so that when you are on another website, you may be shown advertising based on your browsing patterns on our website. We may also show you advertising on our website based on your browsing patterns on other websites that we have obtained from our advertising partners.
